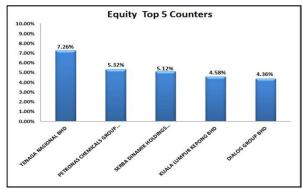






AmMetLife Takaful Equity Fund - NAV

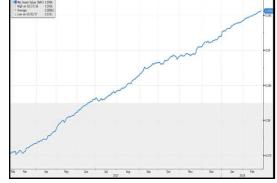

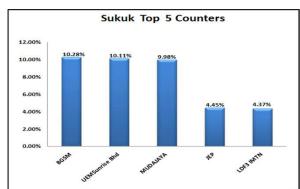


AmMetLife Takaful Sukuk Fund - 1 year Performance

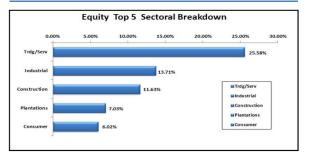

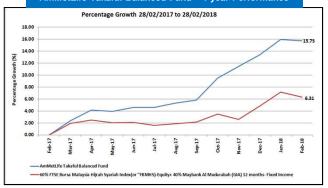

Sukuk Sectoral Breakdown

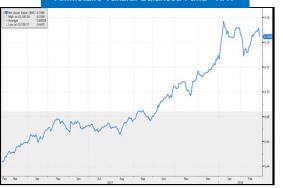

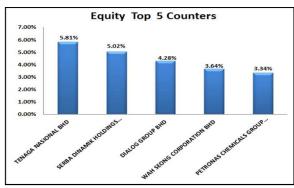


AmMetLife Takaful Balanced Fund - 1 year Performance

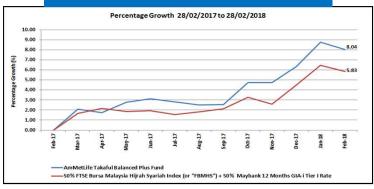

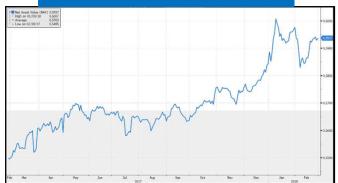
